### **Visitor's Acknowledgement of Risk**

In consideration of the services of Appalachian Mountain Guides, their officers, agents, employees, and stockholders, and all other persons or entities associated with those businesses (hereafter collectively referred to as "AMG") I agree as follows:

Although AMG has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, AMG has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroyed the unique characterizer of the activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. AMG does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all of the those risks.

I understand that risks are associated with rock climbing which could include, but are not limited to falling, protection failure, gear misuse or failure, and exposure to inclement weather including, but not limited to snow, lightning, rain, and/or sleet. I understand that accidents or lines can occur in remote places without medical facilities. I understand rock climbing can be a strenuous activity which should not be participated in by persons with heart or cardiovascular medical problems.

I am aware that rock climbing entrails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary; no one is forming me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different from other activities and that I have responsibilities as a participant. I acknowledge that the staff of AMG has been available to fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.

I have carefully read, clearly understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effecting and binding upon me, my heirs, assigns, personal representative, and estate and for all members of my family, including minor children.
